Couple of new members. Bill Lund and Jon King.


Jeff \$75 and Micah \$50 towards the Club's AeroScout loaner. (Yaz provided a \$75 gift certificate at ABC)

Frequency Pin – let's make an effort to use the FP bars, especially when there's a large group. Only 3 planes at once.


Paul: Sumac needs to be looked at.

## 3 FAA PUBLISHES FINAL RULE ON REMOTE ID — BY JEFF WARD

On December 28<sup>th</sup>, the FAA submitted to the Federal Register their final rule covering "Remote Identification of Unmanned Aircraft". Before you read on, keep in mind that compliance to any of this new stuff is not required until almost three years from now. Until then, the existing rules apply.

#### 3.1 WHAT DID WE GET?

It is encouraging to note that many of the most onerous and restrictive aspects of the originally proposed rule from 2019 have been removed, particularly those that impact those who fly recreationally and particularly at community flying

fields. It's clear that the many of thousands of comments received by the FAA actually did bring significant changes to the rule as originally proposed.

- The establishment of FAA-Recognized Identification Areas (FRIAs) will not be restricted to a 12-month period, which means that the ability to create recreational flying sites will not be time-limited. New sites can be created, and sites that lapse can be re-activated. A
- FRIA is a defined area where unmanned aircraft can be operated without being equipped for Remote ID. It's important to note that FRIAs must be applied for with very specific information, the FAA will not be rubber-stamping these applications, and the specific information and process required to apply for a FRIA is still to be defined. The AMA has stated that it intends to be very involved in the process of helping its clubs apply for FRIAs to cover their flying sites.
- Unmanned aircraft flown outside of FRIAs must broadcast certain information, but the requirement for communicating that information via network connection and 3<sup>rd</sup> party services has been removed. You will not be able to establish your farm or backyard as a FRIA, so once compliance is required, any model that you fly outside of a FRIA (that meets the requirements for registration) must use a "broadcast module" that complies with the Remote ID requirements. The size, weight, cost, and power requirements of such modules are yet to be determined as the market responds to the rule.
- Registration requirements have not changed for recreational fliers, as opposed to the original proposed requirements to register each model, even if only used recreationally. If you are not using a model/drone for commercial purposes, your whole fleet can be covered under your individual registration, as it is now. However, anything that you fly that is eventually equipped for Remote ID broadcast must have its RID serial number recorded under your FAA DroneZone registration. It is believed that in the case of a Broadcast Module, the serial number of the module would be tied to your individual registration, and that module could be moved from model to model as needed.
- The original proposal's overly complex requirements about "homebuilt" systems have been relaxed, and it appears that anything we build or assemble ourselves, short of a Ready-to-Fly system, can be built without integral Remote ID. Again, if it will be flown outside of FRIAs it must support a Broadcast Module.

#### 3.2 What else is in this rule?

In addition to Remote ID (RID) this rule also details requirements for Operations Over People (OOP) and moving vehicles. All of the operations covered under this rule presume Line of Site between the operator and the aircraft. The commercial UAS community of course is looking forward to further rules that cover operation Beyond Visual Line of Site, or BVLOS.

#### 3.3 When does it take effect?

Operators must comply with the requirements of this rule **beginning late in 2023**. However, we will see products being built and sold to comply with the rule in the almost three years leading up to the compliance date.

#### 3.4 In closing...

There are a lot more elements to the rule that are of interest to modelers, and a lot more clarification to come from the FAA and other stakeholders over the implementation period. And keep in mind also that this rule only covers specific topics like RID and OOP. There might be other changes coming that fall outside of the scope of this rulemaking.

## 4 THE CLUB SAFE LOANER - PART 2 - HOW TO ACCESS & FLY IT

Continuing from the previous newsletter, the Club has acquired a brand new ready-to-fly (RTF) AeroScout. Jeff Ward is hosting the aircraft in his workshop. Contact him if you are interested in using it to introduce someone to flying.

He has placed a key box accessible with the proper combination. Below are pictures showing the location of the lock and what it looks like with the enclosure removed, and the lock opened.



Below are pictures of the plane, transmitter and accessories:



Steps for using the Club's AeroScout:

- 1 Contact Jeff Wardand get his address and workshop lock combination.
- 2 Procure the plane and read the brief instructions that go with it. Pay special attention to battery placement notes and SAFE mode switch.
- 3 Charge the 2200 mah battery at 1C (there is only one battery at this time). It is a smart battery but you can charge it with a regular charger. The battery lead is similar in shape to a blue connector.
- 4 Place your FAA UAS registration number on the side of the plane with masking tape.
- 5 Go fly enjoy the plane.
- 6 When finished, notify Jeff. Return the plane to Jeff's workshop. Comminicate any issues with an email or conversation with Jeff.

John Parisi: Yes, flew on Sunday. Worked just fine.


Mel Suarez: Thank you! not too bulky? and is the temperature adjustable?

#### 6.2 Labeling Your Plane for AMA Events – from John Yassemedes

"... At Sanctioned AMA events we should always look for compliance at safety inspection table. As one of your AVPs for District, I ask that all AMA D-I members please take the time to ID your models with your AMA number and Name, tel & AMA number. We are not required to be policing FAA numbers but it is required to be visible without removing anything. Authorities don't want to have to open the model to find identification. Recovered models could be destroyed with disassembling due to safety concerns."





# 7 FROM THE EDITOR — BY MEL SUAREZ

#### 7.1 GOT AN APPRENTICE STS FROM SANTA

I've been thinking of helping with the training load. So, I asked from Santa and received my first Apprentice STS. Just have to bind it and test fly it. Then get super-familiar with it. Then contact the training leadership.
